Registration forms and full payment must be received by Wedding Warriors not later than Tuesday February 7th 2017.

1. Exhibit space will not be reserved without payment.
2. Vendors may begin booth setup at 8am day of the event. All booths must be staffed the entire event time of 11:30 am to 2:30pm. Moving Equipment through aisles while guests are on the floor is discourteous and a safety hazard, so dismantling of displays may not begin until after 2:30pm.
3. There will be no refunds for cancelations.
4. If you want to donate a raffle prize, have them to Maily O'Neil by Monday February 13th 2017. You must fill out the prize section of the registration form.
5. Exhibitors must limit noise levels to acceptable levels.

6. Any and all damages to the ballroom that is specific to a vendor are at the expense of that vendor. All decorations sound/ electrical equipment or supplies must be provided by the exhibitor.
7. All exhibitors and their employees must confine their activities to their exhibit space. Handouts (including literature, souvenir items and promotional materials) may be distributed only from your display space, not from the aisle.
8. Vendors must provide proof of Liability Insurance.
